The geographical scope of research in this series includes ancient Egypt, Sudan and adjacent areas (extending from Libya down to the Horn of Africa), and it covers a chronological period stretching from Prehistory to early Late Antiquity (c. 4000 BC–400 AD). The series encourages research that engages with these areas from different angles: from texts to literature, from museum studies to material culture, from archaeometry to landscape archaeology, and from history to anthropology.
