- political and anti-heretical crusades within Europe
- the military religious orders

- vernacular literature of the crusades
- text editions and translations

While open to all relevant topics within these broad fields, the series will be particularly receptive to works on more specialised topics such as crusading warfare, prosopography and biography, the Baltic Crusades, and the practice and ideology of crusading in the later Middle Ages and the Early Modern period.
